Thank you for your recent Freedom of Information request about IESO. Please find our response below.

### Contract

- a) When did the contract with IESO commence? **19 March 2018**
- b) When is the contract with IESO due to expire? **31 March 2020 following a recent renewal**

### Contacts/Number of Patients/Sessions

- c) How many of your patients has IESO seen since the contract commenced? (or on a yearly basis). **209**
- d) How many individual sessions (both at step 2 and step 3, including assessments) has IESO conducted with your Patients since the contract commenced (total number of sessions plus assessments)? **1081**
- e) How many sessions are IESO obliged to provide (or how many patients are they contracted to see) during the term of their contract? **The contacted with 1000 step 3 patients on a waiting list, with an uprate of 25%. For 2019/20 there are approximately 420 patients in Gloucestershire and 180 patients in Herefordshire.**
- f) Are there limits to the number of session that IESO can provide to patients? **No**
- g) What is the average number of sessions that IESO provide for your clients? **5.2**

### Outcomes

- h) What are the outcomes (recovery rates) for these sessions? – eg Average recovery rates. **40.2%**
- i) Are there specific elements of the contracts about recovery rates for patients? **IESO are contracted to match the recovery rate of the service.**

### Supervision

- j) Do IESO provide clinical supervision to the clinicians who provide therapy for your patients? **Yes**

### Funding

- k) What was the total amount paid to IESO during the contract? **For 2018/19, the Trust paid a total of £122,898 to IESO. For 2019/20, the Trust has paid £187,950 for Gloucestershire and £80,904 for Herefordshire.**
- l) How much are IESO paid per session? **This can be calculated from the information stated above.**

m) How much are IESO paid per course of treatment per patient? The backlog clearance cost is not set per course of treatment.
