Thank you for your recent Freedom of Information request. Please find the Trust's response below.

The request relates to the total number of patients, bed days and their associated cost who were placed in out of area (private) beds for the financial year 2017/2018. This should relate to either provider of CCG funded activity and exclude specialist placements commissioned by NHS England. I would be grateful if the data could be broken down into CAMHs, adult and older adult split between general needs and PICU for each.

Where we do not provide a service the table has been left blank.

The data relates to those patients placed in a private out of area bed where the provider had limited or no capacity. The analysis excludes specialist placements commissioned by NHS England. Please note; 2gether NHS Foundation Trust does have other Out of Area patients who's placements are not caused by a shortage of inpatient beds. These placements are for care and treatment services that are commissioned by the CCG but are not available in Gloucestershire.
