Re: Freedom of Information Request – Ref: FOI 123-1819

Thank you for your recent Freedom of Information request about under 18s on adult wards. Please find the Trust's response below.

1. On how many occasions has a child (under the age of 18) been treated on an adult ward during each calendar year from 2010 to 2018 (Year to Date) inclusive. Please detail how long the child remained on the adult ward, what treatment they received and why they were treated on an adult ward (e.g. staffing shortages).

Please note there are no Tier 4 CAMHS beds in Gloucestershire. If mental health admission is indicated then an out of county bed has to be sourced which can take time. During the time taken to source an out of area bed it may be necessary to admit the young person to our Adult inpatient services in the interests of theirs or others safety. These decisions are made on a case by case basis and involve conscious decision making and agreement based on risk management considering the young person to be admitted and the environment they will be admitted to i.e. patient needs/mix in the Adult inpatient service at that do not escalate risks either way. As a Trust we work hard to discharge children and young people from adult wards at the earliest convenience to an age appropriate out of area bed. For some young people 17.5+ however, we may decide based on risk assessment and clinical need, that it is in the young person's best interest to remain close to home rather than to send them out of county where they would be some distance from their families and social circles. Again these decisions are made on a case by case basis and there is not a blanket policy.

Whenever a young person under 18 is admitted to our Adult Services inpatient unit, CAMH's colleagues will attend the ward and work with the ward team to assess need and develop a tailored treatment plan for their brief stay.
