Freedom of Information Request – Ref: FOI 311-1819

Thank you for your recent Freedom of Information request about EU Exit preparation. Please find the Trust's response below.

- 1. Have you appointed a senior responsible officer for EU Exit preparation? If so, who is it and what is their existing job title with the trust? **Andrew Lee, Director of Finance and Commerce**
- 2. All NHS trusts and foundation trusts have been asked to undertake internal reviews/selfassessments of purchased consumables, goods and services (non-clinical) to understand any risks to operations if there is disruptions in supply in the event of a no-deal EU exit. Please send your trust's review/self-assessment.

With respect to this, we have followed the Department of Health and Social Care (DHSC) operational guidance to support our business continuity planning for a no-deal EU Exit scenario and we are taking the necessary steps to ensure we are operationally ready for the proposed EU Exit as the situation develops. With respect to this, we have followed the Department of Health and Social Care (DHSC) operational guidance to support our business continuity planning for a no-deal EU Exit scenario and we are taking the necessary steps to ensure we are operationally ready for the proposed EU Exit as the situation develops. Information is being co-ordinated by the Local Resilience Forum.

Assessment Request – this request is refused under Section 36(2)9c) – prejudice the effective conduct of public affairs.

4. All NHS trusts and foundation trusts were told to undertake local risk assessments to identify any staff groups or services that may be vulnerable if there is a shortfall of EU nationals. Please confirm if you have carried out such assessments, and if you have please send the assessments.

Our assessment is that the impact on our workforce will be negligible given the smaller numbers of EU staff employed in Gloucestershire and Herefordshire. We have identified no single point of failure services. In view of the small number which make individual services and the staff working within them identifiable, we cannot provide this data. The Trust has widely publicised the NHS Pilot EU Settlement Scheme which was open to NHS staff until 21st December 2018 in advance of the wider scheme roll-out planned for March 2019. It continues to offer individual support to impacted staff.
