Freedom of Information Request – Ref: FOI 122-1718

Thank you for your recent Freedom of Information request. Please find the Trust's response below.

- Has your mental health trust signed an agreement with the Clinical Commissioning Group that meets the mental health investment standard for each of the years 2017/18. 2018/19 and 2019/20.
 - We have two main CCG commissioners, being Gloucestershire CCG and Herefordshire CCG. With regard to Gloucestershire CCG the 2 year contract signed in December 2016 meets the mental health investment standard for 2017/18, and we expect it to for 2018/19 also with discussions to confirm this to take place in the autumn. With regard to Herefordshire CCG the 2 year contract signed in December 2016 does not meet the mental health investment standard for either 2017/18 or 2018/19, but Herefordshire CCG are financially challenged and in deficit and we did achieve investment equal to at least the same level invested in other services (eg acute). Contracts for 2019/20 have not yet been discussed, but we would expect to negotiate a position that meets the mental health investment standard for both CCG's.
- How many non-fatal suicide attempts were there in the trust in (a) 2014/15, (b) 2015/16 and (c) 2016/17
 - a) 2014/15 11
 - b) 2015/16 7
 - c) 2016/17 9
- What was the (i) mean, (ii) highest and (iii) lowest wait for patients within the trust requiring an acute inpatient mental health bed in (a) 2014/15, (b) 2015/16 and (c) 2016/17. The Trust does not hold this information.
- What was the (i) mean, (ii) highest and (iii) lowest wait for patients within the trust requiring a Tier 4 CAMHS bed in (a) 2014/15, (b) 2015/16 and (c) 2016/17. **The Trust does not hold this information.**
